## OFFICIAL RULES NASHVILLE SUPERSPEEDWAY "12 DAYS OF GIVEAWAYS" PROMOTION

## NO PURCHASE NECESSARY. OPEN ONLY TO LEGAL U.S. RESIDENTS 21 YEARS OR OLDER AT TIME OF ENTRY. VOID WHERE PROHIBITED OR RESTRICTED.

**4. Sweepstakes Drawing:** Sponsor will utilize an electronic random selection program to determine potential prize winners. Sponsor's decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion.
